

NICS: Gun Sales for August 2021 Second Highest on Record


In August of 2021, National Instant Background Check System (NICS) and the associated gun sales are at high levels, but not as high as the record sales in 2020. The August sales of 2021 are the second-highest on record, as were the July sales in 2021.

This may indicate a new normal of consistently high gun sales, below the record-setting levels of 2020.

There were about 1.29 million gun sales recorded by NICS this past August. In 2020, gun sales were about 1.67 million. The next highest August was in 2016, with about 1.17 million gun sales.

These consistently high gun sales in 2020 may come from political unrest, lack of faith in the electoral system, and millions of new gun owners. In 2020, estimates of new gun owners varied between 4 and 8 million. This correspondent has not seen any surveys showing a percentage of new gun owners for 2021. There have been about 12.5 million firearm sales through federally licensed dealers in 2021 by the end of August. There were about 13.5 million sales by the end of August in 2020.

Since the election of President Obama in 2012, about 168 million guns have been added to the privately-owned stockpile in the United States. Nearly all of those guns are



not registered. Only a few states require the registration of guns.

Most of the approximately 476 million guns in private hands in the United States are unregistered and untraceable.

The estimate of guns sold is uncertain because not all sales go through the NICS system. About 10 million people with carry permits may purchase guns through federal dealers without going through the NICS system because they already went through the NICS to obtain their carry permit. The 10 million is an estimate because half of the states have this system. There are more than 20 million people in the United States with carry permits. One person may purchase several guns with one NICS check.

There were about 2.70 million NICS checks in August of 2021. Most of those were for permit checks and rechecks. Illinois and Kentucky run multiple rechecks of carry permits each month. This skews the system with more than twice as many NICS checks as there are firearm sales.

A general shortage of ammunition may account for the slight slackening of gun sales. Demand has outstripped production. President <u>Biden</u> <u>has placed a ban</u> on future imports of guns and ammunition from Rus

U.S. COPYRIGHT OFFICE - FAIR USE DEFINITION:

One of the rights accorded to the owner of copyright is the right to reproduce or to authorize others to reproduce the work in copies or phonorecords. This right is subject to certain limitations found in sections 107 through 118 of the copyright law (title 17, U.S. Code). One of the more important limitations is the doctrine of "fair use". The doctrine of fair use has developed through a substantial number of court decisions over the years and has been codified in section 107 of the copyright law.

Section 107 contains a list of the various purposes for which the reproduction of a particular work may be considered fair, such as criticism, comment, news reporting, teaching, scholarship, and research. Section 107 also sets out in four factors to be considered in determining whether or not a particular use is fair:

- The purpose and character of the use, including whether such use is of commercial nature or is for nonprofit educational purposes
- 2. The nature of the copyrighted work
- The amount and substantiality of the portion used in relation to the copyrighted work as a whole
- 4. The effect of the use upon the potential market for, or value of, the copyrighted work

The distinction between fair use and infringement may be unclear and not easily defined. There is no specific number of words, lines, or notes that may safely be taken without permission. Acknowledging the source of the copyrighted material does not substitute for obtaining permission.

The 1961 Report of the Register of Copyrights on the General Revision of the U.S. Copyright Law cites examples of activities that courts have regarded as fair use: "quotation of excerpts in a review or criticism for purposes of illustration or comment; quotation of

short passages in a scholarly or technical work. for illustration or clarification of the author's observations; use in a parody of some of the content of the work parodied; summary of an address or article, with brief quotations, in a news report; reproduction by a library of a portion of a work to replace part of a damaged copy: reproduction by a teacher or student of a small part of a work to illustrate a lesson: reproduction of a work in legislative or judicial proceedings or reports; incidental and fortuitous reproduction, in a newsreel or broadcast, of a work located in the scene of an event being reported."

Copyright protects the particular way an author has expressed himself. It does not extend to any ideas, systems, or factual information conveyed in the work.

The safest course is always to get permission from the copyright owner before using copyrighted material. The Copyright Office cannot give this permission.

When it is impracticable to obtain permission, use of copyrighted material should be avoided unless the doctrine of fair use would clearly apply to the situation. The Copyright Office can neither determine if a certain use may be considered fair nor advise on possible copyright violations. If there is any doubt, it is advisable to consult an attorney.

sia, which may re-inflate the ammunition bubble.

Ammunition manufacturers all around the world are running at high levels, attempting to meet the demand. There were signs of a <u>deflating ammunition bubble</u> before the fiasco in Afghanistan and the <u>Biden</u> <u>ban on Russian importation</u>.

The times are uncertain. A rising power (China) threatens world stability. The leadership of the dominant power (the USA) seems feckless, hesitant, and incompetent, unwilling to offend the rising power. There are substantial reports of family corruption.

This correspondent does not see a significant reduction in demand for

ammunition or firearms in the near future.

As gun sales rise the number of people with carry permits soar, and the number of gun owners increase, support for and exercise of Second Amendment rights continues to rise.

The number of people who want restrictions on gun ownership, sales, and usage is shrinking.



HR 4225 and S2319 - 3D Printed Gun Safety Act of 2021

Technology has changed a great deal since the Bill of Rights was ratified in 1791. This is beyond dispute, and it is something that Second Amendment supporters have to deal with when trying to convince their friends, family, and neighbors to back our Second Amendment rights against certain assaults.

Anti-Second Amendment extremists often claim that the Founders had no clue that something like the AR-15 could exist and as such, it is not protected by the Second Amendment. Well, that argument is bullshit, and in a way, the Supreme Court has already said so. In <u>Caetano v.</u> <u>Massachusetts</u>, Massachusetts saw its ban on stun guns get thrown out on Second Amendment grounds.

One could argue that stun guns are/were even less likely to be predicted or anticipated by the Founders.

So, when we look at the 3D Printed Gun Safety Act of 2021, introduced by Representative Ted Deutch (D-FL) in the House as <u>HR 4225</u> and by Senator Ed Markey (D-MA) in the



Senate as $\underline{S 2319}$, we see a clearly unconstitutional piece of legislation on Second Amendment grounds. It is hard to imagine this bill not being struck down by the Supreme Court, especially when one considers the current alignment.

Both Markey and Deutch have appalling records on Second Amendment issues, but with this bill, they are also attacking the First Amendment as well.

As the summary for S 2319 puts it, "This bill makes it unlawful to intentionally publish digital instructions for programming a three-dimensional printer to make a firearm."

When AmmoLand News covered <u>an</u> <u>earlier iteration</u> of the bill, the major news then was about then-New Jersey Attorney General Gurbir Grewel's <u>attempt to bully</u> <u>CodelsFreeSpeech.com</u>. A ruling <u>out of the Ninth Circuit</u>, of all places, seems to be putting the kibosh on that front. But the fight will go on in Congress and state legislatures. One of the things Second Amendment supporters will have to confront is that 3D printing and programmable CNC machines are going to be game-changers in the field of firearms manufacturing. For one thing, it could be possible for manufacturers to put out-of-production guns back on the market via blueprints for a 3D printer – for instance, allowing someone to make a replica of a Smith and Wesson 1076, which has been out of production since 1993.

Second Amendment supporters need to contact their Senators and Representatives and politely urge them to oppose HR 4225 and S 2319. In addition, they need to support pro-Second Amendment organizations and work to defeat anti-Second Amendment extremists in office at the federal, state, and local levels via the ballot box as soon as possible.

HR 4953, the National Firearms Amendments Act of 2021

One reason that we will still need strong pro-Second Amendment organizations after favorable rulings like ones covering standard magazines and modern multi-purpose semiautomatics is because, as we noted earlier, bans will not be the only way that anti-Second Amendment extremists will come after our rights. We noted earlier the threat that could be posed by <u>expanding</u> the coverage of the National Firearms Act.

For any loyal Ammoland readers who were skeptical of that earlier piece, I present to you <u>HR 4953</u>, the National Firearms Amendments Act of 2021, sponsored by Representative Theodore E. Deutch (D-FL). Eight other representatives have co-sponsored this bill, and this one is a massive attack on those who wish to exercise the rights protected by the Second Amendment.

This bill takes any semiautomatic rifle or shotgun, modern or not, that can accept a detachable magazine and makes it subject to the NFA. All the red tape, all the penalties for not registering, all of the other restrictions will get applied with a bill that is three pages long, should it be signed into law.

What makes this bill a potentially devastating attack is the fact that it could easily be included as part of a reconciliation bill, and since the NFA is part of the tax code, a filibuster could be evaded as a result. You will note that this bill was referred to the House Ways and Means Committee, which covers taxes.

But we can't assume that just the additional hoops in the legal sense will be the only hit that Second Amendment supporters would take. We could see a secondary attack through financial blacklisting/de-platforming of manufacturers and/or retailers who would refuse to stop selling allegedly "dangerous" firearms to the general public. The fact of the matter is that we cannot afford to rest on the laurels of any court victory. The courts can only handle one sort of case at a time. The case is slated to be heard in November, and the cases from California will only close off certain attacks - there will be other avenues that will be used by our enemies to attack our rights. And yes, anti-Second Amendment extremists who seek to punish us for horrific crimes and acts of madness that we did not commit. and then smear us as child killers or domestic terrorists can rightly be viewed as enemies of those who wish to exercise our riahts.

Second Amendment supporters need to contact their Representative and Senators and politely urge them to oppose HR 4953, and to instead support legislation like the <u>Home</u> <u>Defense and Competitive Shooting</u> <u>Act</u>. In addition, anti-Second Amendment extremists at the federal, state, and local levels need to be defeated at the ballot box as soon as possible.

Quick Reference Guide to U.S. Firearms Laws

I. POSSESSION OF A FIREARM OR AMMUNITION BY A PROHIB-ITED PERSON:

<u>18 USC § 922(g) & (n)</u>. Punishable by up to 10 years imprisonment. May receive minimum sentence of 15 years without parole if offender has three or more prior convictions for a felony crime of violence (e.g. burglary, robbery, assault, possession of offensive weapons) and/or drug trafficking felony.

Elements

A. Possession or receipt of a firearm or ammunition;

B. By a subject who falls within one of the following categories:

<u>Felon</u> - (Additionally, persons awaiting trial on felony charges are prohibited from receiving firearms.);

<u>Drug user or addict</u> - (Often shown where paraphernalia seized, subject tests positive for drugs and/or subject claims drugs were possessed for personal use.);

<u>Alien</u> - (Includes illegal aliens and aliens lawfully admitted under nonimmigrant visas, i.e., those aliens not admitted for permanent residence. This provision does not prohibit aliens who lawfully possess a so-called "green card" from possessing guns or ammunition.);

<u>Is subject to a domestic restraining</u> <u>order</u> - (The order must prohibit contact with an intimate partner, or child of the subject, and must have been issued only after a hearing of which the subject was notified and at which the subject had an opportunity to participate. The order must also find the subject poses a threat to the physical safety of the intimate partner or child or must prohibit the use, threatened use or attempted use of physical force.);

Has a prior conviction for domestic assault - (Includes a prior conviction

for any assault or threatened use of a deadly weapon against a present or former spouse or partner or child or guardian of any such person. The subject must have been entitled to a jury trial and been represented by counsel in the prior proceeding or be shown to have waived those rights.);

<u>Fugitive from justice</u> - (Fled any state to avoid being prosecuted or to avoid testifying in any criminal proceeding.); or

Dishonorably discharged from the military; AND

C. The firearm or ammunition was transported across a state line at any time.

II. KNOWINGLY SELL, GIVE OR OTHERWISE DISPOSE OF ANY FIREARM OR AMMUNITION TO ANY PERSON WHO FALLS WITHIN ONE OF THE ABOVE CATEGORIES:

<u>18 USC § 922(d)</u>. Punishable by up to 10 years imprisonment.

III. USE, CARRY OR POSSESS A FIREARM IN RELATION TO OR IN FURTHERANCE OF A DRUG FELONY OR A FEDERAL CRIME OF VIOLENCE:

<u>18 USC § 924(c)</u>. Punishment ranges from at least 5 years up to life imprisonment, without parole, or death if death results from use of firearm. Sentence must be served consecutive to any other sentence. Mandatory minimum sentence increases depending upon: the type of firearm involved (sawed-off gun, silencer, etc.); whether more than one offense was committed; and whether gun was simply possessed or was brandished or discharged.

IV. STOLEN FIREARM, AMMUNI-TION OR EXPLOSIVE:

<u>18 USC §§842(h): 922(i). (j) & (u)</u>. Punishable by up to 10 years imprisonment.

A. May not receive, possess, conceal, store, pledge or accept as security for a loan, barter, sell or ship or transport across a state line any stolen firearm, ammunition or explosive.

B. May not steal or unlawfully take or carry away a firearm from the person or premises of a firearms licensee.

V. FIREARM IN A SCHOOL ZONE:

<u>18 USC § 922(q)(2)(A)</u>. Punishable by up to 5 years imprisonment.

A. Except as authorized, may not possess or discharge a firearm in a school zone.

VI. KNOWINGLY POSSESS OR MANUFACTURE:

<u>18 USC § 922(k). (o) & (v): 26 USC</u> § <u>5861</u>. Punishable by up to 5 or 10 years imprisonment, depending upon specific violation.

A. Any <u>machine gun</u>, fully automatic firearm or any part designed or intended exclusively for use in such weapon;

B. Any <u>firearm silencer</u>, including any device, or part thereof, designed to silence, muffle or diminish the report of a firearm;

C. <u>Sawed-off shotgun</u> with a barrel length of less than 18" or overall length less than 26";

D. <u>Sawed-off rifle</u> with a barrel length of less than 16" or overall length less than 26";

E. Destructive device;

F. <u>Semi-automatic assault weapon</u> manufactured after October 1, 1993; OR G. <u>Any firearm which lacks a serial</u> <u>number or contains an altered or</u> <u>obliterated serial number</u>.

VII. SELL, DELIVER OR TRANS-FER TO A JUVENILE:

<u>18 USC § 922(x)(1)</u>. Punishable by up to 1 year imprisonment unless transferor had reason to believe juvenile would commit crime of violence with gun or ammunition, then up to 10 years imprisonment.

<u>18 USC § 922(b)</u>. A firearms licensee faces up to 5 years imprisonment.

A. May not sell, deliver or transfer a handgun or handgun-only ammunition to a person who is under age 18;

B. A person under age 18 may not possess a handgun or handgun-only ammunition; (Certain exceptions apply to A & B, such as where juvenile possesses written permission of a parent.);

C. A firearms licensee may not sell any gun or ammunition to anyone

under the age of 18 and may not sell a handgun or handgun ammunition to a person under the age of 21.

FORFEITURE OF FIREARMS, AMMUNITION & EXPLOSIVES:

<u>18 U.S.C. §924(d)</u> authorizes the seizure and forfeiture of firearms, ammunition and explosives involved in criminal offenses. However, strict time limitations are imposed. Consult the ATF or U.S. Attorney's Office as soon as possible for guidance on forfeiture issues.

TRACING OF FIREARMS:

Firearms information for every firearm, even if only identified during a field interview or traffic stop, should be sent to ATF for tracing and possible connection to other criminal activity.

DEFINITION OF "FIREARM":

Any weapon (including a starter gun) which will expel a projectile by means of an explosive or is designed or may be readily converted to do so. This includes the frame or receiver of any such weapon, any firearm muffler or silencer or any destructive device.

A "destructive device" includes any explosive, incendiary or poison gas --- (i)bomb; (ii) grenade or (iii) similar device, or any combination of parts designed or intended to be converted into a destructive device, or from which a destructive device may be readily assembled. Does not include black powder or antique type firearms. <u>18 USC §921(3)</u>.

Breaking Down The Biden-Russian Ammunition Ban - Real Numbers

The Biden Ban on the importation of Russian ammunition has caused much confusion within the gun world. <u>AmmoLand</u> News has reached out to multiple sources in the firearms industry on and off the record to clear up the confusion and to understand the real impact on American shooters.

Biden claims to have ordered the ban in response to the poisoning of Russian opposition leader and Putin critic Alexei Navalny. Most gun rights advocates argue that Biden used the poisoning of Mr. Navalny as an excuse to enact backdoor gun control since Russian arms and ammunition imports to the U.S. account for less than 1% of the entire Russian economy.

First, know the ban on Russian imported ammunition was not immediate. The prohibition went into effect September 7th 2021. That does not mean no more ammunition will come into the country as of that date, but just that new ammo import permits will no longer be issued. Existing importation permits for ammunition and arms are good for 24 months, meaning any effect to the supply chain will take about two years for the gun owners to see. There are approximately [rough estimates, no one actually knows the exact number] 1.5 billion rounds of Russian ammunition currently in the pipeline to be imported over the next two years.

According to the global small arms and ammunition research group, <u>Small Arms Analytics</u>, in 2020, companies imported 770 million rounds of ammunition from Russia. The total number of imported rounds of ammunition from all sources is 3.5 billion. That means Russian ammo

accounts for just over 22% of all imported ammunition to the United States.

It is harder to get a total number of domestically produced rounds. Still, it is understood in the industry that companies import 25% of the ammunition sold in the U.S. All industry sources AmmoLand News reached out to agree that Russian ammo accounts for between 5% and 8% of total ammo sold in the country. The number more accurately is between 5% and 6%. Chief Economist Jurgen Brauer of Small Arms Analytics agrees with the number AmmoLand News obtained.

"Russia has been the U.S.'s largest external ammunition supplier for 16 years running," Brauer told Ammo-Land News.

"While the total number of rounds in the U.S. market is not known, it is likely that Russia supplies about 5% of the U.S. market. The impact will not be immediate as the U.S. Customs and Border Protection service apparently will honor existing import permits even if shipments arrive after the U.S. deadline.

"Despite the circumstances, it is perhaps helpful for U.S. shooters to learn that a very substantial part of U.S. ammunition supplies, or parts thereof, come from overseas. After Russia, the next four top suppliers in 2020 were Italy, Mexico, Turkey, and Germany."

Breaking Down The Biden-Russian Ammunition Ban - Real Numbers

One of the calibers that will be the hardest hit will be the 5.45×39 round used in AK74 type firearms. Almost all 5.45×39 ammunition comes from Russia. Several sources outside Russia produce the round, but none import to the U.S. or have plans to import to the U.S. because most of their rounds are sold to Eastern European militaries. The 5.45×39 A.K. variants make up less than 10% of the total A.K.s in the country.

The tooling cost to produce 5.45×39 ammunition would be prohibitive. It would be hard for companies to recoup the cost of retooling their machines to produce the round. Also, that would mean making less of another round that sells better in the U.S. Right now, the demand for the round would not justify the investment. The demand is up now because of the Biden ammo ban, but companies worry that demand will drop.

However, under new leadership, the Biden Russian ammunition ban can be easily reversed. It is only a political sanction. Companies worry that if they retool for rounds such as 5.45×39 and the embargo is lifted they will have to against mother Russia's higher production rates. Then they would have wasted money since they would not be able to recoup the cost of producing the tooling. One silver lining is that it would not take an act of Congress to restart the importation of Russian ammunition. If Republicans are successful in the next Presidential election cycle, the new President will have the power to remove the sanction with a stroke of a pen.
