# NRA-ILA: More Legislation for Government to Ignore?

We've been saying for years - decades, to be honest - that Amer-ica does not need any more restrictions on firearms to combat violent criminals who misuse guns; we simply need to enforce the laws that are already on the books. Our argument has always been that passing new laws will only affect the otherwise lawabiding, responsible gun owners the anti-gun crowd keeps claiming to support their "sensible" proposals.

Violent criminals will always ignore gun laws, just as they ignore the myriad other laws that make them violent criminals.

But it seems these criminals are not the only ones who ignore gun laws. So does the federal government, according to President Biden. If you don't believe us, just listen to what he actually said.

"And to your point, Mr. Baker, regarding the lack of prosecutions on lying on Form 4473s, we simply don't have the time or manpower to prosecute everybody who lies on a form, that checks a wrong box, that answers a question inaccurately."



Biden said this in 2013, back when he was President Obama's vice president, and he was speaking to former NRA-ILA Executive Director Jim Baker, who was serving as NRA-ILA Director of Federal Affairs at the time.

This statement was made by Biden during an Obama-administration meeting as part of its then-promotion of a raft of new gun laws. NRA had agreed to attend the PR event to explain its position, and Biden's response came after Baker had just pointed out, as we have pointed out many times before and since, that new laws are not what America needs.

Clearly, the Obama/Biden team was not interested in enforcing existing laws, only in passing new ones.

Of course, we're not saying that anyone who gets denied a firearm purchase through NICS should be prosecuted, as the system is far from perfect and results in a number of false denials. Also, some prohibited individuals, especially those with old or obscure convictions, might not even realize that they are legally prohibited from purchasing a firearm.

You see, when people try to buy a firearm through a Federal Firearms Licensee (FFL), or what most simply call a gun store, they fill out a federal

# **BELOW THE RADAR: More Legislation You Need to Know About**

# HR 405 - LEAD Act

Attacks on our right to keep and bear arms don't just take the form of gun bans or universal background checks. If anything, anti-Second Amendment extremists have always been scheming to find ways to make it harder to exercise our rights, and some of them are quite diabolical in the way many Second Amendment supporters do not see them coming.

One such bill is <u>HR 405, the LEAD</u>
Act, introduced by Ted Lieu, a congressman from California (no surprise, a Democrat). In this case LEAD stands for Lead Endangers Animals Daily, and it bans the use of traditional ammunition on lands the United States Fish and Wildlife Service has jurisdiction over. For a first offense, there is a \$500 fine, with additional offenses leading to fines from \$1,000 to \$5,000.

When compared to the sentences that occur from violating 18 USC 924, these seem mild, and this bill seems like it isn't a big deal at first glance. But it actually hits those who wish to exercise their Second Amendment rights hard in multiple ways. One of the worst is that Lieu's proposed ban, based on an Obama Administration "" that President Trump overturned, hits their pocket-book.

Traditional ammo is relatively cheap, even in a time where a gun store can sell a shipment of 80,000 rounds in 30 minutes. For many who acquire firearms for hunting, person-



al protection, or just plain target shooting, it's not just about buying the gun. They need to make sure it is sighted in properly, that they have an idea of what ammunition works best for them, and that they have sufficient proficiency with that firearm/ammo combination to safely use it. That takes a lot of rounds.

Now bad can the hit be? For example, a box of 25 non-toxic shotgun shells runs for over \$40 at SportsmansGuide.com. Assuming you'd have enough proficiency and confidence in a shotgun/shell combo after firing 250 rounds, that's \$400 before one single "for real" use. By comparison, a box of 25 traditional shells runs for about \$13 at that same site. Assuming the same 250 rounds for proficiency and confidence, that is a difference of \$270 enough to buy a FMK semiauto pistol from Sportsman's Guide (following all state and federal laws, of course).

Of course, this is the real reason for the bill – to make exercising Second Amendment rights unaffordable. Second Amendment supporters should contact their Representatives and Senators and politely urge their opposition this legislation. Second Amendment supporters should also support the NRA's <u>Institute for Legislative Action</u> and <u>Political Victory Fund</u> to ensure that the current anti-Second Amendment regimes in the House, Senate, and White House are defeated at the ballot box as soon as possible.

# HR 647 - Closing the Loophole on Interstate Firearm Sales Act

To anti-Second Amendment extremists, anything that allows a lawabiding American citizen to exercise their Second Amendment rights is a "loophole." Second Amendment supporters, though, often find people questioning this mindset – often because they don't know the current laws, how little they are enforced, or what anti-Second Amendment extremists ultimately want to subject this country to.

Well, Second Amendment supporters now have a concrete example of this mindset from anti-Second Amendment extremists, and they can thank Representative Jason Crow (D-CO). Crow has introduced HR 647, the Closing the Loophole on Interstate Firearm Sales Act, with nine co-sponsors.

Under current law as laid out in 18 USC 922(b), it is legal to buy for a resident of one state to buy a long gun from a federal firearms licensee in another state provided the laws of both states are followed. This makes things more convenient for a resident of the northern panhandle of West Virginia, who could find a long gun they wish to buy in either Ohio or Pennsylvania that would be much closer than the nearest FFL with that same gun in West Virginia. This is not an exclusive situation - the same would apply in a number of other regions in the country, like the Delmarva peninsula, the eastern panhandle of West Virginia, and much of New England.

For most Second Amendment supporters, this situation is inconvenient, but far less so than if they were limited to only buying from FFLs in their state. If anything, with NICS, there is no logic to restricting the sale of any firearm across state lines (not to mention the various waiting period and licensing schemes some states have).

# Jason Crow, though, thinks of this as a "loophole."

In a press release, he cannot cite a single actual horrific act, just a panic over a sale that already violated the existing provisions of the law! Even then, over this honest mistake on the part of an FFL, Crow wants to punish thousands of people over a panic.

Now, to be fair, the FFL should have taken the time to look up Florida's laws – there is a summary on the NRA-ILA website – before the sale was completed. Because of that FFL's mistake, anti-Second Amendment extremists have gained a pretext to justify pushing a new burden on our rights. We do not deserve to be punished for an honest mistake.

Second Amendment supporters should contact their Representatives and Senators and politely urge them to oppose HR 647, and instead seek to override state waiting periods and licensing schemes. They also should support the NRA's Institute for Legislative Action and Political Victory Fund to ensure that the current anti-Second Amendment regimes in the House, Senate, and White House are defeated at the ballot box as soon as possible.

# HR 125 - the Gun Safety: Not Sorry Act

Representative Sheila Jackson Lee has not been a friend of law-abiding gun owners – or anyone who values the Second Amendment. If anything, she has been very active, and has introduced some of the most onerous proposals we have seen. But, like Dianne Feinstein in the last Congress, she is not averse to more modest bills to unjustly punish those who seek to exercise their Second Amendment rights for horrific acts they did not commit.

In this case, her fallback is <u>HR 125</u>, the Gun Safety: Not Sorry Act. Rather than a sweeping licensing and registration scheme that is deeply intrusive, it instead imposes a oneweek waiting period for any semi-automatic firearm, many standard magazines (like those for a Glock 17), suppressors, and "armorpiercing ammo."

We've discussed the waiting period scam before. Put your thoughts about the tactics used to limit the damage done by the Brady Act in 1993 aside. Suffice it to say, when the national instant background check system (NICS) is up and running, there is no justification for a waiting period. If a person is not prohibited, they should be able to take their purchase home with them the moment NICS reports it is a legal transaction.

The fact is, most handguns sold today are semiautos and many of those semi-autos have magazines that normally hold more than 10 rounds. The commonality of the I atter is such that a federal judge threw out California's magazine ban citing the simple text from the Heller

decision that commonly-owned firearms are protected – a decision a Ninth Circuit panel has upheld. So, Sheila Jackson Lee wants to make you wait for the type of firearm that is most likely to be useful for selfprotection. (Not that revolvers are bad guns, per se, or ineffective, but semiautos have taken the lion's share for perfectly valid reasons.)

Now, if you want to keep bad guys from getting guns, the waiting period is, at best, superfluous. The fact is, instant checks can deny the purchase, and if there are federal, state, or local authorities who are serious about enforcing laws regarding attempts by those prohibited from owning firearms to obtain them, there are ways to actually arrest and prosecute them. So what is the real purpose of the waiting period? It's not to solve the purported problem Representative Jackson Lee claims to be addressing.

Second Amendment supporters should contact their Representatives and Senators and politely urge their opposition to this unjust bill, and ask that they instead support legislation like the Protecting Communities and Preserving the Second Amendment Act, which actually addresses the misuse of firearms and does not infringe on our rights. Second Amendment supporters should also support the NRA's Institute for Legislative Action and Political Victory Fund to ensure that the current anti-Second Amendment regimes in the House, Senate, and White House are defeated at the ballot box as soon as possible.

# HR 1004 -Firearm Risk Protection Act

When we discussed financial deplatforming, we noted that for the firearms industry – in fact, even for those who want to buy firearms – access to financial services, including banking is a must. If access to those services are denied, say through a re-started Operation Choke Point, then the Second Amendment becomes a dead letter.

But now, Representative Carolyn Maloney (D-NY) wants to require people to show proof of insurance to be able to buy a firearm. She introduced HR 1004 with one co-sponsor, Representative Andre Carson (D-IN). While text of this bill is not available as of this writing, Representative Maloney has introduced this bill in the 116th and 115th Congresses as the Firearm Risk Protection Act.

The text of the legislation as introduced in the 115th Congress states it is unlawful to buy a firearm without a "qualified liability insurance policy" and it is also illegal to sell to someone without said "qualified liability insurance policy." The definition the text provides is vague, beyond saying that the policy should provide "liability insurance covering the purchaser specifically for losses resulting from use of the firearm while it is owned by the purchaser."

It is not an overstatement to say that Second Amendment supporters can figure out just what sorts of mischief can take place. Operation Choke Point is just the start. Given the constant social stigmatization surrounding not just the exercise of Second Amendment rights, but against those who use the First Amendment to advocate in defense of our Second Amendment rights, some insurance agents may not want the business at all. In addition, there is no guarantee that insurance companies won't engage in a form of "redlining" against certain firearms.

Even if those things don't happen, the insurance is going to be yet another monthly expense for those exercising our Second Amendment rights. Even then, there would be questions: Would a new gun require an adjustment in the policy? Would rates go up for those with larger collections? The list goes on and on.

This legislation is not intended to address any problems with the misuse of firearms – or even accidents. What it is intended to do is to make exercising Second Amendment

rights such a hassle people will decide to give them up. Second Amendment supporters should contact their Representatives and Senators and politely urge their opposition this legislation. Second Amendment supporters should also support the NRA's Institute for Legislative Action and Political Victory Fund to ensure that the current anti-Second Amendment regimes in the House, Senate, and White House are defeated at the ballot box as soon as possible.

# Home Defense and Competitive Shooting Act of 2021

We've noticed that at times, bad bills have turned up in Congress multiple times. Sheila Jackson Lee and Carolyn Maloney have both done this, with the latest versions of monstrosities introduced in past Congresses being HR 127 and HR 1004. We noted in the last Congress Bobby Rush had done the same with the Blair Holt Firearm Owner Licensing and Record of Sale Act, albeit that has not been formally introduced in the 117th Congress as of this writing.

However, it should be noted that re-introduction of legislation in Congress after Congress is a tool. That means that pro-Second Amendment measures can similarly be brought back by lawmakers who seek to protect our rights, not punish us for crimes and acts of madness we did not commit. One such piece of legislation is the Home Defense and Competitive Shooting Act of 2021.

In the 116th Congress, it was introduced by Roger Marshall of Kansas. Marshall, though, is unable to introduce it in the House this year. That's because he ran for the Senate to fill a seat being opened by retirement, and he won that election. So, someone else has to sponsor this bill in the House. Representative H. Morgan Griffith of Virginia has done just that.

The benefits we noted when this bill came up in the 116th Congress are

still there, and these days, there are new benefits to consider. The more guns that can be moved off registries, the better. But it also takes a lot of riddles from the very ponderous NFA system and into NICS. It's not a perfect situation, but it represents a substantial improvement.

Now, given the current state of things in Washington D.C., this legislation doesn't stand much chance, is any, of passing. Anti-Second Amendment extremists control the House, Senate, and White House. It will be very hard to get it through the lengthy process to pass legislation. It will likely die in the House Judiciary Committee.

This is the sort of bill, though, that can be useful gauge. We know the facts, and Second Amendment supporters should be asking candidates and elected officials about their position on this bill. Once they have this information, they must act accordingly, depending on whether the position supports our rights, or seeks to infringe on them. And as always, Second Amendment supporters should support the NRA's Institute for Legislative Action and Political Victory Fund to ensure that the current anti-Second Amendment regimes in the House, Senate, and White House are defeated at the ballot box as soon as possible.

# February 2021 NICS 2nd Highest Gun Sales on Record

(AmmoLand.com)- The number of National Instant background Check System (NICS) checks done in February of 2021 was another record for the month. The number of NICS done for firearms sales was the second-highest February ever. This shows the expansion of the NICS for uses other than firearms purchases is continuing.

To find a close approximation of the number of NICS used for firearm sales in February, we add the number of handgun checks to long gun checks, to 2.5 x multiple checks, plus the other firearms checks.

In February of 2021, there were about 1.35 million NICS checks done for firearm sales. The highest February was in 2016 when the number was 1.41 million checks done for firearms sales.

The total number of NICS checks done in February of 2021 was 3.44 million. Nearly 61% were done for things other than firearms sales. The most prominent of those things were 1.48 million checks done for firearm carry permit rechecks, as well as .53 million checks done for firearm carry permits.

The total number of private firearms in the United States is now about 468 million. The number is calculated using the methods pioneered by Newton and Zimring, and extended by Gary Kleck in "Point Blank: Guns and Violence in America". The numbers from 2020 and 2021 so far, are an approximation based on the NICS numbers.

Actual manufacturing and import numbers will be released by the ATF for 2020 in about a year.

The number is the cumulative addition of domestic manufacture plus imports minus exports. It does not count guns shipped to the U.S. military.

Because of the inherent imprecision involved, the figures are rounded to the nearest million.

The reasons for the high level of firearms sales are clear. The political division in the United States is high.

Conservative voters fear the government and distrust the media. Progressive and Democrat voters trust the government and fear Conservatives. Progressive politicians preach distrust of the police and the military, which have been Conservative strongholds for decades.

When distrust of major institutions rises, people consider what they can do to rely on their own resources.

Firearms represent personal power. Niccoló Machiavelli often considered a founding father of modern state politics, wrote of the difference in attitude between armed and unarmed people. From "The Prince":

There is no comparison whatever between an armed and disarmed man; it is not reasonable to suppose that one who is armed will obey willingly one who is unarmed; or that any unarmed man will remain safe.... – Niccoló Machiavelli, The Prince. 1537.

Mao Zedong wrote:

"Political power grows out of the barrel of a gun."

Political power is the primary reason for the Second Amendment. If the people are to be sovereign, they must be armed.

The United States population is the best-armed in the world, although the Swiss, for a long time, were strong contenders. Of the estimated small arms existing in the world (about 1.11 billion), residents of the United States own 42%.

It seems unlikely the current trend to center all power in the bureaucracy in Washington, D.C. can continue without dealing with an armed American population.

The American system was designed to prevent such an accumulation of power in the District of Columbia. The Constitution has been subverted and its checks and balances undercut through propaganda, legislative and judicial acts of "Progressivism" for most of a hundred years.

The incongruities between the nominal structure of the Constitution and the realities of the administrative state are causing great stress.

One response is for people to buy guns and ammunition. Another is for the ruling elite to crackdown on dissent, and to double down on propaganda.

Most of the ruling class power in the United States rests in the control of the flow of information to the people.

Propaganda loses its value as more and more people refuse to believe it.

Mere numbers of armed people are insufficient to check organized power. There must be organization as well.

One of the checks designed to prevent the accumulation of power in D.C. is the power of States to resist. More states are resisting. Their political structure allows for the organizing of their populations' armed power.

With luck, enough faith will be restored in the fairness of elections, to prevent all-out violent confrontations.

# Feinstein-Cicilline AWB Legislation: 'Treason' Say Gun Activists

As House Democrats, joined by eight Republicans, were passing two background check bills, anti-gun Sen. Dianne Feinstein (D-CA) and Rep. David Cicilline (D-RI) were introducing legislation to ban so-called "assault weapons," fulfilling with lightning speed a prediction from national gun rights advocate Alan Gottlieb

Chairman of the Citizens Committee for the Right to Keep and Bear Arms (CCRKBA), Gottlieb said House passage of the extremist background check measures would "open the pathway" for even worse legislation. While his remarks were aimed at Rep. Sheila Jackson Lee's H.R. 127 - mandating gun owner licensing, registration, psychological examination, mandatory gun-owner insurance, and prison for non-compliance - he could just as easily been talking about Feinstein's longsought ban. CCRKBA is currently running a nationwide TV campaign to warn gun owners about this legislation.

Taking to social media, New Jersey attorney and rights advocate Evan Nappen wrote that the 35 people signing onto Feinstein's legislation were "Oath-Breakers, Rights-Takers, Gun Bigots, Liberty-Haters, Bought & Owned by Bloomturd (and) Pearl-Clutchers."

Nappen was alluding to Feinstein and her co-sponsors: Senators Chris Murphy (D-Conn.), Richard Blumenthal (D-Conn.), Charles E. Schumer (D-N.Y.), Dick Durbin (D-III.), Edward J. Markey (D-Mass.), Brian Schatz (D-Hawaii), Bob Menendez (D-N.J.), Tom Carper (D-Del.), Sherrod Brown



(D-Ohio), Maggie Hassan (D-N.H.), Jeff Merkley (D-Ore.), Sheldon Whitehouse (D-R.I.), Bernie Sanders (I-Vt.), Elizabeth Warren (D-Mass.), Bob Casey (D-Pa.), Tim Kaine (D-Va.), Jack Reed (D-R.I.), Mark R. Warner (D-Va.), Mazie K. Hirono (D-Hawaii), Ron Wyden (D-Ore.), Ben Cardin (D-Md.), Chris Coons (D-Del.), Tina Smith (D-Minn.), Cory Booker (D-N.J.), Chris Van Hollen (D-Md.), Jacky Rosen (D-Nev.), Tammy Duckworth (D-III.), Amy Klobuchar (D-Minn.), Ben Ray Luján (D-N.M.), Alex Padilla (D-Calif.), Patty Murray (D-Wash.), Kirsten Gillibrand (D-N.Y.), Jeanne Shaheen (D-N.H.) and Debbie Stabenow (D-Mich.).

(NOTE: Colorado's two Democrat Senators did not co-sponsor the bill, but don't count on them not to vote for it when it reaches that point. -Ed.)

Those agreeing with Nappen's premise accused backers of the bills of "treason."

According to Fox News, Feinstein noted in her introductory statement, "It's been 17 years since the original Assault Weapons Ban expired. To be clear, this bill saves lives. When

it was in place from 1994-2004, gun massacres declined by 37 percent compared with the decade before. After the ban expired, the number of massacres rose by 183 percent.

"We're now seeing a rise in domestic terrorism, and military-style assault weapons are increasingly becoming the guns of choice for these dangerous groups. I'm hopeful that with the new administration and Democratic control of the Senate, we can finally pass common sense gun reforms to remove these deadly weapons from our communities."

Cicilline chimed in, "Assault weapons are designed for a single purpose – to kill as many people as possible in as short an amount of time as possible. That's why they are the weapon of choice for mass shooters and domestic terrorists. They are weapons of war and do not belong in our communities. Banning these weapons will make our cities and towns safer and more secure and help to reduce gun deaths."

Feinstein's announcement included a list of key provisions:

- Bans the sale, manufacture, transfer and importation of 205 military-style assault weapons by name. Owners may keep existing weapons.
- Bans any assault weapon with the capacity to utilize a magazine that is not a fixed ammunition magazine and has one or more military characteristics including a pistol grip, a forward grip, a barrel shroud, a threaded barrel or a folding or telescoping stock. Owners may keep existing weapons.
- Bans magazines and other ammunition feeding devices that hold more than 10 rounds of ammunition, which allow shooters to quickly fire many rounds without needing to reload. Owners may keep existing magazines.
- Requires a background check on any future sale, trade or gifting of an assault weapon covered by the bill.
- Requires that grandfathered assault weapons are stored using a secure gun storage or safety device like a trigger lock.
- Prohibits the transfer of high-capacity ammunition magazines.

 Bans bump-fire stocks and other devices that allow semi-automatic weapons to fire at fully automatic rates.

Right upfront in Feinstein's bill there is this notation: "To regulate assault weapons, to ensure that the right to keep and bear arms is not unlimited, and for other purposes." (Emphasis added.)

You read that right. This legislation acknowledges it is designed to limit the right to keep and bear arms. The legislation may be read here.

More than 2,200 firearms are exempted by name. They are apparently acceptable firearms for "hunting, household defense or recreational purposes."

But what about for carry outside the home for self-defense? Maybe Capitol Hill anti-gunners are leaving that to the states. In Washington State, for example, a House hearing was slated on S.B. 5038, a bill aimed at criminalizing open carry at public rallies, especially at the state Capitol in Olympia.

According to an email alert from the National Rifle Association, "This horrible piece of legislation would prevent you from open carrying any firearms or other weapons at any public demonstrations or even our state Capitol, a clear violation of your 2nd Amendment rights.

"But...it gets worse. This bill extends liability to anyone within 250 feet of the protest, regardless of on foot or in a personal vehicle. This legislation would only hurt legal gun owners."

The hearing before the House Committee on Civil Rights & Judiciary began March 16. It is not clear how much traction the Feinstein-Cicilline ban legislation will gather, but it provides more evidence that a) When Democrats have a majority they move swiftly to ratchet down on gun rights, and b) Elections matter.

However, the New York Post noted in its report, "The bill...faces long odds in the evenly split Senate, where 60 votes usually are required for bills. A companion bill introduced in the Democrat-held House by Rep. David Cicilline (D-RI) could have a better chance in the lower chamber."

The Post story noted something else that should, but probably won't, give Congressional anti-gunners pause: "Proposals to ban guns typically result in gun owners rushing to buy more of them."

Feinstein's office released a fact sheet (actually a booklet) that defined the weapons in her legislation. Read it here.

# NRA-ILA: More Legislation for Government to Ignore?

form (Form 4473), and are then vetted through the National Instant Criminal Background Check System (NICS) to determine if they are prohibited under federal law from purchasing a firearm.

If you fill out the form accurately, and you are actually prohibited from purchasing a firearm, the form will tell you so. The call to NICS is really to determine if the person who filled out the form has lied about their legal status, which violates federal law.

After NICS has been contacted, roughly 1% of the millions of NICS checks run each year result in denials. Last year, there were nearly 40 million checks run, although that number was well above normal, so let's look at prior years to put this into some perspective. Before 2020, the number of annual checks averaged about 25 million, so there was an average of about 250,000 denials each year. If a denial is legitimate, then that likely constitutes a federal crime, as the form filled out probably claimed the purchaser was not prohibited.

Now, we know that quite a few of those denials are errors, as countless people have appealed their I nitial denial and been later approved. But, many individuals incorrectly denied may never appeal, so we do not know the total "false positive" rate for NICS.

In addition, many people who try to buy a gun but are prohibited from doing so by law likely have no idea they are in such a position; especially considering anti-gun extremists are constantly working to expand the list of prohibited individuals.

It's easy to imagine a 60-year-old who wants to purchase a gun being denied because they committed an illegal act in their 20s that was not a prohibitive offense, but the offense now disqualifies them from making a lawful purchase.

Similarly, there are likely some who have been convicted of committing prohibitive offenses but were never told their offense meant they could no

longer lawfully purchase a firearm. Many prohibitive offenses, after all, are crimes that are not violent - think tax violations and other financial crimes - so it is not at all inconceivable that many would not consider such violations to be the reason for infringing on someone's rights protected under the Second Amendment.



There are certainly those who knowingly try to violate the law. Even if you exclude all the NICS denials that are errors and the ones that are for people who did not know they were prohibited, there are still likely several thousand individuals who are career criminals who, every year, knowingly try to make an illegal purchase in the hope that they could beat the system. Remember, these are actual criminals and are knowingly attempting to get around the law.

Getting career criminals off the streets, especially those who are clearly identified as breaking the law by trying to unlawfully acquire a firearm, should be a priority for all law enforcement. They've even made the job of investigating their criminal activities much easier, as they have literally told the government they are trying to commit yet another crime.

Shouldn't the federal government investigate these crimes? According to 2013 Joe Biden, the answer is "No." Today, things are not much different. Biden, now as president, is again pushing a raft of new gun laws. Included in this latest round of assaults on the Second Amendment are attempts to again expand the list of people prohibited from purchasing firearms, expand the list of firearm transfers that are subject to being run through NICS to include virtually all transfers—under the guise of "universal" background checks-and allow unelected government bureaucrats to

wipe out the "instant" in NICS with the power to arbitrarily delay and prevent lawful frearm transfers indefinitely.

But if Biden wasn't interested in having the federal government investigate and prosecute career criminals who tried to illegally acquire firearms in 2013, it's unlikely he's interested in doing so in 2021.

In other words, Biden's goal of expanding the list of prohibited persons, expanding the scope of NICS to cover private transfers, and allowing indefinite delays on NICS-subject transfers has nothing to do with stopping violent criminals. It is all about expanding the scope of federal authority and advancing his agenda of diminishing the Second Amendment to the point of irrelevance.

To be clear, the expansion of NICS to all firearm transfers (even temporary loans) will do nothing to deter violent criminals from being violent criminals, but it will lay the foundation for yet more federal expansion of gun restrictions. Specifically, mandatory registration of all firearms and firearm owners. After all, there is no way to "ensure" private transfers of firearms are run through NICS without knowing who currently has which guns.

Again, if Biden and the anti-gun extremists were serious about addressing violent crime in America that involves firearms, they would drop their efforts to expand their control that will only impact law-abiding gun owners, and focus on going after career criminals who have proven they don't care about local, state, or federal restrictions on their violent, criminal activities.

Drop the façade of promoting more "reasonable" gun control and enforce the laws already on the books that can be used against these predators.

The Institute for Legislative Action (ILA) is the "lobbying" arm of the National Rifle Association of America. ILA is responsible for preserving the right of all law-abiding individuals in the legislative, political, and legal arenas, to purchase, possess, and use firearms for legitimate purposes.

Small Arms Lexicon and Encyclopedias, Chester Mueller and John Olson, Shooter's Bible, South Hackensack, News Jersey, 1st Ed., 1968

Joshua Stevens (1814-1907) - American gunsmith and inventor who began to manufacture under his own name after working for Samuel Colt for several years. He began making pistols and revolvers in 1864.

**John Taliaferro Thompson (1860-1940) -** Brigadier General in the Army's Ordnance Dept. who designed a .45 cal. air-cooled submachine gun. It

was first marketed in 1921, becoming popularly known as the "Tommy Gun"

**Lt. Edward W. Very USN** - Inventor of the Very Pistol, use to fire signal flares.

**Paul Marie Eugene Vieille (1854-1934** - French engineer, designed the first smokeless rifle powder for the French Army, building on earlier work by Pelouze and Braconnet in 1832.

James Watt (1736-1819) - American inventor of the steam engine. He worked with Rev. Alexander John Forsyth inventing several percussion locks.

W.R. Weaver - Manufactured rifle scopes under the trademark Weaver-scope

Philip and James Webley - formed an English manufacturing firm that eventually became Webley & Scott, Ltd. One of several firearms made was a .455 cal. Six-shot revolver used by the British Army from 1887-1947

**Daniel Baird Wesson (1825-1906)**Americans gunsmith and manufacturer of revolvers and cartridges who joined with Horace Smith, founding the company Smith & Wesson.

Townsend Whelen (1877-1961) - Hunter, target shooter and author of several articles and books. He served for 40 years in the U.S. Army reaching the rank of Colonel. At the Ordnance Dept., He commanded Frankford Arsenal and was later Director of Research and Development at Springfield Armory.

Rollin White (1818-1892) - American guns and inventor who worked at Colt's Armory. In 1855, he invented and patented a revolver cylinder which allowed loading from the rear. He sold the rights to Daniel B. Wesson in 1856.

Eli Whitney (1765-1825) - American inventor of the cotton gin and manufacturer of firearms. He pioneered the concept of interchangeable parts in 1798. He worked with Samuel Colt in his first revolver manufacturing enterprise.

**John Wilkinson (1728-1808)** - An ironmaster and inventor who, in 1789, received a British patent for a barrel with two spiral grooves. He is also credited with building the first boring machine in 1775.

Oliver Winchester (1810-1880) - An American manufacturer of rifles and pistols, best known for the production of the B. Tyler Henry repeating rifle.


