#### The Firearms Coalition of Colorado 10-18-2023 Legislative Alert- Lessons learned from Hamas attack

On Saturday, 10-07-2023, terrorists from the Palestinian nationalist group Hamas attacked Israel from the Gaza Strip, killing well over 1,000 men, women, and children. The Israeli civilian victims were largely helpless, because of their country's restrictive gun control laws. (Only around 2 % of civilians were legally armed.) Following the massacre of these innocents, the Israeli Government is loosening some firearms restrictions. We believe there are valuable lessons to be learned from this tragedy.

The time for allowing citizens to defend themselves from crime and terror is before the fact, not after. We often hear the lament from people in favor of gun control, "If it only saves one life…" How many lives would have been saved if more of the families destroyed by terrorism had firearms immediately available for self-defense?

Israel has well-organized police and military forces, but the fact remains that official first responders are seldom going to be available to prevent terrorism and other crimes. In this case, the officially designated government defenders were caught off guard. Tragedy often strikes quickly, and only an immediate response from armed adults among the intended victims offers a chance of survival. This reality is a strong argument for programs that train willing and able school personnel to deter and immediately oppose potential mass killers, as well as a reason for widespread civilian gun ownership. We should learn from the violence that engulfed Israel, so we can avoid the consequences of Ben Franklin's warning, "Experience keeps a dear (expensive) school, yet fools will learn in no other." Let us learn from history and not repeat mistakes that lead to avoidable tragedies.

We believe the best way to protect Americans from crime and terrorism is a groundswell of political activism from Second Amendment supporters that sweeps the anti-gun elements from power in fully transparent, honest, and fair elections. Please support election integrity efforts, such as True the Vote. Support pro-individual rights candidates from the most pro-Second Amendment major political party. A third-party vote or a protest vote is a wasted vote. Mike Rosen is right. "Party trumps person!" The party in power at any level controls the political/legislative process and the agenda. The Courts cannot protect us forever.

The next election cycle is underway. If pro-Second Amendment supporters do not gain in this upcoming round, there may not be a way to use the political process to restore sanity and justice to our state and country. With every victory, the Left further consolidates power and further entrenches its partisan operatives in every level of government bureaucracy.

#### The Firearms Coalition of Colorado 10-9-2023 Proposed BATFE Rule on "Gun Dealers"

If you have not yet commented on the Bureau of Alcohol, Tobacco, Firearms, and Explosives (BATFE) proposed rule that would change the definition of who is a "gun dealer" subject to regulation by the bureau, please do so. The comment period expires on **12-07-2023**. We urge you to weigh in on what we consider to be a serious overreach of BATFE authority.

The regulatory change apparently hinges on the mere intention to sell firearms mainly to earn a "profit." Citizens who sell firearms at gun shows could be considered dealers in firearms under the new rule and may be required to obtain a Federal Firearms License (FFL). Offering to sell even one firearm could trigger the license requirement under certain circumstances. Along with the Administration's current Draconian "Zero-Tolerance" crackdown on FFLs, this move seems intended to cripple gun shows, chill individual gun sales, put as many firearms sellers as possible under the thumb of the BATFE, and to ultimately decimate gun transfers.

Exemptions might be made for individuals selling guns from their individual "collections," subject to what seem to be dangerously vague conditions. Significantly, owning firearms for the purpose of self-defense does not seem to qualify as having a "collection," under the proposed rule.

We believe the proposal exceeds the authority of the BATFE under current law. We also believe that the apparent lack of clarity in the pending rule invites abuse by an agency with an historical bias against the private ownership of firearms.

### Notice of Proposed Rulemaking; Request for Comment

#### Summary

The Department of Justice ("Department") proposes amending Bureau of Alcohol, Tobacco, Firearms, and Explosives ("ATF") regulations to implement the provisions of the Bipartisan Safer Communities Act ("BSCA"), effective June 25, 2022, that broaden the definition of when a person is considered "engaged in the business" as a dealer in firearms other than a gunsmith or pawnbroker. This proposed rule incorporates the BSCA's definition of "predominantly earn a profit," creates a stand-alone definition of "terrorism," and amends the definitions of "principal objective of livelihood and profit" and "engaged in the business" to ensure each conferme with the BSCA's detutory. and profit" and "engaged in the business" to ensure each conforms with the BSCA's statutory changes and can be relied upon by the public. The proposed rule also clarifies what it means for a person to be "engaged in the business" of dealing in firearms, and to have the intent to "predominantly earn a profit" from the sale or disposition of firearms. In addition, it clarifies the term "dealer," including how that term applies to auctioneers, and defines the term "responsible person." These proposed changes would assist persons in understanding when they are required to have a license to deal in firearms. Consistent with the Gun Control Act ("GCA") and existing regulations, the proposed rule also defines the term "personal collection" to clarify when persons are not "engaged in the business" because they make only occasional sales to enhance a personal collection, or for a hobby, or if the firearms they sell are all or part of a personal collection. This proposed rule further addresses the lawful ways in which former licensees, and responsible persons acting on behalf of such licensees, may liquidate business inventory upon revocation or other termination of their license. Finally, the proposed rule clarifies that a licensee transferring a firearm to another licensee must do so by following the verification and recordkeeping procedures instead of using a Firearms Transaction Record, ATF Form 4473.

Written comments must be post-marked and electronic comments must be submitted on or before December 7, 2023. Commenters should be aware that the electronic Federal Docket Management System will not accept comments after midnight Eastern Time on the last day of the comment period.

This includes any personal identifying information ("PII") submitted in the body of the comment or as part of a related attachment. Commenters who submit through the Federal eRulemaking portal and who do not want any of their PII posted on the internet should omit PII from the body of their comment or in any uploaded attachments. Commenters who submit through mail should likewise omit their PII from the body of the comment and provide any PII on the cover sheet only. Fair use is a doctrine in the United States copyright law that allows limited use of copyrighted material without requiring permission from the rights holders, such as for commentary, criticism, news reporting, research, teaching or scholarship. It provides for the legal, non-licensed citation or incorporation of copyrighted material in another author's work under a four-factor balancing test. The term "fair use" originated in the United States. A similar principle, fair dealing, exists in some other common law jurisdictions. Civil law jurisdictions have other limitations and exceptions to copyright.

#### U.S. COPYRIGHT OFFICE - FAIR USE DEFINITION:

One of the rights accorded to the owner of copyright is the right to reproduce or to authorize others to reproduce the work in copies or phonorecords. This right is subject to certain limitations found in sections 107 through 118 of the copyright law (title 17, U.S. Code). One of the more important limitations is the doctrine of "fair use". The doctrine of fair use has developed through a substantial number of court decisions over the years and has been codified in section 107 of the copyright law.

Section 107 contains a list of the various purposes for which the reproduction of a particular work may be considered fair, such as criticism, comment, news reporting, teaching, scholarship, and research. Section 107 also sets out in four factors to be considered in determining whether or not a particular use is fair:

- 1. The purpose and character of the use, including whether such use is of commercial nature or is for nonprofit educational purposes
- 2. The nature of the copyrighted work
- 3. The amount and substantiality of the portion used in relation to the copyrighted work as a whole
- 4. The effect of the use upon the potential market for, or value of, the copyrighted work

The distinction between fair use and infringement may be unclear and not easily defined. There is no specific number of words, lines, or notes that may safely be taken without permission. Acknowledging the source of the copyrighted material does not substitute for obtaining permission.

The 1961 Report of the Register of Copyrights on the General Revision of the U.S. Copyright Law cites examples of activities that courts have regarded as fair use: "quotation of excerpts in a review or criticism for purposes of illustration or comment; quotation of short passages in a scholarly or technical work, for illustration or clarification of the author's observations; use in a parody of some of the content of the work parodied; summary of an address or article, with brief quotations, in a news report; reproduction by a library of a portion of a work to replace part of a damaged copy; reproduction by a tecacher or student of a small part of a work to illustrate a lesson; reproduction of a work in legislative or judicial proceedings or reports; incidental and fortuitous reproduction, in a newsreel or broadcast, of a work located in the scene of an event being reported."

Copyright protects the particular way an author has expressed himself. It does not extend to any ideas, systems, or factual information conveyed in the work. The safest course is always to get permission from the copyright owner before using copyrighted material.
