

Enabled by legislation passed by Liberals in the State Legislature, the State Office of Gun Violence Prevention has created a campaign to provide information about compliance with Colorado's oppressive gun laws, and less helpfully, in our opinion, provide information about how to turn in gun owners because they just might be a danger to themselves or to others. Topics include:

Safe Firearm Storage - Locking up guns makes them useless for self-defense. "Safe Storage" has pretty much taken long guns out of the legal home defense equation in Colorado, unless you want to walk around your house with a rifle on a sling.

Lost or Stolen Firearms - Most people report stolen guns, because they want them back. Persons prohibited from gun ownership don't have to report, because it would be self-incrimination. This law, which requires reporting, is a "good step" toward universal gun registration, a necessary precursor to confiscation.

Mental Health and Substance Misuse Issues - Keep in mind that medical personnel and mental health workers can now file extreme risk protection orders against their patients and clients.

Extreme Risk Protection Orders (ERPOs) - Here we are in Minority Report territory, where police agencies, relatives and the professionals mentioned above can put a gun owner in a position to be confronted by police, who have been advised that he or she is a potential threat, without meaningful up-front due process. What could possibly go wrong? (Google: Gary Willis, ERPO. He did not survive the process after his sister "red flagged" him after a family squabble.)






