

The Firearms Coalition of Colorado 10-16-2024 Legislative Alert- Ballots Are Out- Vote ASAP

<u>Please vote early, if you are registered with the major pro-gun party.</u> This easy action reduces the workload for people who are "chasing" ballots. Once you vote, they don't have to keep calling and texting to remind you. They can focus their efforts on other citizens. This also reduces the wear and tear on your phone. <u>Voting early eliminates the possibility of a last minute emergency keeping you from casting your critical ballot.</u>

Talk to your friends to make sure they have voted. Same day registration means there is no excuse for not exercising this most basic right and responsibility.

<u>Vote all the way down the ticket</u>. Local officials have a great deal of influence over how you live your life. 


