

## Colo. Lawmakers Introduce Semiauto Ban Bill

Colo. Lawmakers Introduce Semiauto Ban BillSeveral Democratic Colorado state Senators and Representatives introduced a wide-ranging bill to ban all semiautomatic firearms with detachable magazines from manufacture, distribution, transfer or sale. A violation of the proposed law would be a Class 2 misdemeanor for the first offense, escalating to a Class 6 felony for second or subsequent offenses. The proposed legislation is clearly counter to the U.S. Supreme Court's Heller holding that entire classes of firearms in common use for lawful purposes cannot be banned. While the bill doesn't ban possession, it makes it illegal to legally acquire semiautomatic firearms. NSSF is adamantly opposed to the legislation and is closely monitoring.

Our Democratic legislators wasted no time introducing another gun ban; SB25-0003 was introduced on Wednesday (day one of the current session). These nitwits are positioning this new law as an extension of the large-capacity magazine ban. They don't know much about guns and gun safety. I've heard this is boilerplate from Bloomberg.

Criminals, by definition, don't concern themselves with laws. If you are intent on violating murder laws that go back to the Bible, a piddly-ass law from our legislators means nothing. You are the real target of this bill.

Calling or emailing legislators is effective. If they think their constituents are against a bill, they may moderate it (or even kill it) in committee. You can testify online and in person as this winds through the legislative process.

I've included the 2025 legislative directory, which includes names, districts, party affiliations, emails, phones, etc. Writing or calling any legislator is exactly what democracy is all about. Don't limit yourself to your representative or senator. Write or call as often as you can to as many as possible. Frequently, Legislative staffers provide an aggregate number of those for and against a bill without providing email details. Don't be shy about "stuffing the ballot box".

Polis historically has not supported large-scale gun bans, which don't play well on the national stage. He is term-limited and looking for his next gig. But I would not count on him stopping this bill with a veto.

Heel is a glimmer of hope from the Supreme Court. Four gun cases are in conversation at the Court, two of which directly impact this legislation. I've included a brief description of each.

Don Sheehan City Council District 4 Centennial, Colorado

The US Supreme Court is considering two cases that could negate this bill in time. They have not yet deciided to hear the cases. That could happen this coming Friday (01/17).

The main arguments in **Snope v. Brown** challenge Maryland's ban on certain semi-automatic firearms, categorized as "assault weapons," as unconstitutional under the Second Amendment. Key points include:

Second Amendment Scope: Plaintiffs argue the banned firearms are commonly owned for lawful purposes, such as self-defense, and thus protected by the Second Amendment

Historical Context: The plaintiffs claim Maryland's law lacks historical precedent for restricting firearms based solely on features like pistol grips or flash suppressors

The Ocean State Tactical v. Rhode Island case is significant as it addresses the constitutionality of Rhode Island's ban on large-capacity magazines (LCMs) holding more than ten rounds. Key arguments include:

- **Second Amendment**: Plaintiffs argue the ban violates the right to keep and bear arms, as LCMs are commonly owned for lawful purposes like self-defense.
- **Historical Analysis**: Critics claim the First Circuit misapplied historical tradition by upholding the ban despite no direct historical precedent for such restrictions.
- **Takings Clause**: Plaintiffs contend the law unlawfully forces owners to surrender or modify their property without compensation

Dear (legislator),

I commend your commitment to enhancing public safety, but I strongly urge you to reconsider SB25-003. The bill carries significant legal, economic, and social risks that could ultimately harm Colorado.

### 1. Legal Concerns

Constitutional Challenges: The U.S. Supreme Court's decision in New York State Rifle & Pistol Association, Inc. v. Bruen established that firearm laws must align with historical traditions. SB25-003's broad restrictions risk being struck down as unconstitutional, burdening taxpayers with millions in legal fees.

Precedents: States like California and Illinois have faced repeated legal defeats for similar measures. Colorado's past efforts to enact such laws, like the 2023 and 2024 assault weapons bans, have failed, wasting taxpayer money on doomed initiatives.

#### 2. Economic Consequences

Local Economies: Colorado's firearms industry supports jobs and contributes significantly to tax revenues. SB25-003 could lead to job losses, reduced tax income, and harm to small businesses, particularly gun shops and manufacturers.

Tourism Impact: Restrictive gun laws deter shooting sports enthusiasts and events, reducing tourism revenue.

Fiscal Irresponsibility: With Colorado facing budget constraints, this bill imposes additional financial strain, from enforcement costs to inevitable legal battles.

Misguided legislation targeting tools rather than addressing root causes wastes resources and damages communities. I implore you to pursue thoughtful, effective solutions that respect Colorado's legal, economic, and social realities.

Thank you for considering this perspective. I hope we can find common ground to advance public safety while upholding constitutional rights and fiscal responsibility.

I respectfully disagree with the comment that most semi-auto pistols are not included. Recoil operated might cover a Benelli shotgun but from what I can tell the normal semi-auto pistol would fall under the list of banned mechanisms here:

(V) A BLOWBACK-OPERATED SYSTEM THAT DIRECTLY UTILIZES THE EXPANDING GASSES OF THE IGNITED PROPELLANT POWER ACTING ON THE CARTRIDGE CASE TO DRIVE THE BREECHBLOCK OR BREECH BOLT REARWARD.

But don't worry, Our Attorney General Phil Weiser (who just put his hat in the ring to replace Polis) can put out a list of banned firearms (Section 6, 24-31-120 on page 9) just to clarify which are covered.

"Rapid Fire Devices", defined as anything that increases the rate of fire of a semiautomatic firearm above the standard rate of fire, are illegal to possess as part of this bill as well. Looking at the writeup for that, it appears silencers may already be illegal to possess under Colorado law. Have to check further there!

Regarding:: "RAPID-FIRE DEVICE" MEANS ANY DEVICE, PART, KIT, TOOL, ACCESSORY, OR COMBINATION OF PARTS THAT HAS THE EFFECT OF INCREASING THE RATE OF FIRE OF A SEMIAUTOMATIC FIREARM ABOVE THE STANDARD RATE OF FIRE FOR THE SEMIAUTOMATIC FIREARM..."

So as I see it, that could be interpreted by overzealous gun grabbers to include adding a red dot optical sight or laser designator to facilitate faster target acquisition, adding a bipod, sling or cheek rest to stabilize the aimpoint, or adding a pistol grip, gunstock recoil pad, forward handgrip or muzzle break to minimize the effects of recoil pulling the firearm off the target.

## The Firearms Coalition of Colorado 01-10-2025 Legislative Alert- Session Has Begun- Second Amendment at Risk

The Colorado General Assembly is in session. Nobody's life, liberty or property are safe. The following bills have been introduced in the State Legislature.

**HB25-1055, Repeal Firearm Dealer Requirements and State Permit**, Rep. Brooks. This bill would undo the recently passed requirement in HB24-1353 that a gun dealer have a state permit to do business in Colorado. The proposal also lifts associated requirements for employees of the dealer. Bill has been assigned to the House Business Affairs and Labor Committee. Hearing not yet scheduled. Since the Liberals who passed this legislation are still in control at the Capitol, this bill has little prospect of success. We do support the measure.

**HB25-1062, Penalty for Theft of Firearms**, Reps. Armagost and Duran, Sen. Hinrichsen. This proposal makes theft of any firearm a Class 6 Felony, removing guns from the current sentencing structure that is based on the value of the item stolen. Assigned to the House Judiciary Committee. Not yet scheduled. The bill has bi-partisan support. We support this legislation.

SB25-003, Semiautomatic Firearms and "Rapid Fire Devices" Ban, Sens. Sullivan and J. Gonzales, Reps. Boesenecker and Froelich. This measure bans the manufacture, distribution, transfer, sale, and purchase of any long gun and any "gas operated" handgun with a magazine well. It also bans possession of any "device, part, kit, tool, accessory, or combination of parts" that increase the rate of fire of a semiautomatic firearm. Assigned to Senate State, Veterans and Military Affairs Committee, where Sen. Sullivan is Vice-Chair. Not yet scheduled. Bill has numerous Liberal Co-sponsors in both houses. We vehemently oppose this bill on the grounds it is dramatically unconstitutional, will destroy commerce in firearms in the state, and is a "good step" toward a ban on possession of semi-auto firearms.

**SB25-034, Voluntary Surrender of the Right to Purchase a Firearm**, Sen. Kipp, Rep. Bosenecker. This bill allows an individual to make himself or herself a prohibited person regarding firearms ownership. Assigned to Senate State, Veterans and Military Affairs Committee. Not yet scheduled. We believe this bill to be a classic solution in search of a problem. It also threatens to metastasize into a permanent involuntary ban at some future time. We oppose.

Please contact your State Senator and Representative in response to these measures. If you come down to the Capitol, no guns, or sharp objects of any kind. No signs inside the building. No clothing with political slogans. No food, hats, or beverages, other than bottled water, in the hearing room. No camo or hunter orange. Sport coat and tie OK. You will have to go through a metal detector and may be asked to remove your belt and pass the buckle through the machine. Come early and plan to stay late. Come into the Capitol through the south ground floor entrance. Double check the schedule. Hearing details can change. Plan to leave the Capitol in groups. You will be unarmed in a bad neighborhood.

This link will work for in-person testimony, remote testimony, or for the submission of written testimony. Your remote testimony can be either video, or audio only. After you sign up, you should receive an e-mail with additional instructions. A link and a phone number are available, if you have problems accessing the above testimony link. You can sign up on the link once the bill is placed on the committee schedule. It is probably a good idea to sign up early.

Colorado is looking to ban huge swaths of firearms that are responsibly owned and operated by Coloradans in all 64 counties. This new ban introduced last week would ban the sale or transfer of almost all Modern Sporting Rifles (MSRs) which would include AR-15s, AR-10s, and AK platforms, along with other rifles, shotguns, and handguns.

The National Sport Shooting Foundation estimates there were over 24 million MSRs in the United States in 2022. That means these firearms are "common-use," which is an important legal distinction

Heller vs. D.C. advanced the protection of the Second Amendment by stating that firearms currently "in common-use" are protected from bans put forth by the government.

Since Modern Sporting Rifles are protected from such prohibitions, why would so many Colorado State Senators not only support but also officially sponsor such an expansive ban?

Are they looking for brownie points from Bloomberg and Soros? Do they lack information about how this ban is unconstitutional? Do they know it's unconstitutional and not care? Do they want to try to overstretch pro-gun organizations by passing laws that will get tied up in the courts?

Whatever the reason is, we will not stand for it. We will always stand against infringements of our gun rights. CSSA is committed to defeating this bill in the state legislature and governor's office. If the ban becomes law, we will explore every legal option. We and our allies across the state and the nation defeated a county ordinance similar to this bill in a 2020 lawsuit.

Again. United States Supreme Court precedent demonstrates that this bill is not constitutional.

We are on the right side of history and truth, but CSSA is only as strong as our supporters. We need you to join us to defeat this and future anti-gun bills here in Colorado. We have defeated bans twice in as many years, gun grabbers lost three seats in the Colorado State House, and lost a congressional seat due to the efforts of gun owners and Second Amendment supporters across the state.


